We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a corporation under the NON-PROFIT CORPORATION ACT (D.C. Code 2001 edition, Title 29, Chapter 3), adopt the following Articles of Incorporation:

**FIRST:** The name of the corporation is Conflict Solutions International, Inc.

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purposes for which the corporation is organized are to:

- 1) Study, research and analyze conflict and disputes in various parts of the world;
- 2) Provide advice and expertise;
- 3) Serve as early warning mechanism and help monitor and implement agreements;
- 4) Conduct fact finding missions;
- 5) Educate the public about issues involved in areas of conflict as well as the role of the United Nations and the relevant international agreements;
- 6) Educate parties to a conflict about their rights under UN and other international agreements;
- 7) Promote dialogue and peaceful resolution of disputes among parties in conflict.
- 8) Act as mediators and negotiators among parties in conflict;
- 9) Any other activities that can aid in the resolution of conflicts and disputes.

**FOURTH:** The Corporation shall not have members.

**FIFTH:** Directors of the Corporation shall be elected or appointed in the manner provided for by the bylaws.

**SIXTH:** The internal affairs of the Corporation shall be governed by the bylaws, provided that:

- 1) In the event of the final dissolution of the Corporation, all assets shall be liquidated and the proceeds donated to a nonprofit organization in the United States to be selected by the directors;
- 2) directors of the Corporation shall not be paid for their function as directors;
- 3) officers of the corporation shall be paid in accordance with their experience and not in excess of the rate of pay of other officers with similar experience in other comparable organizations.


